General Questions about the Requirement

- Q34. Could Public Services and Procurement Canada re-visit whether catalyzed varnish will be accepted in lieu of catalyzed lacquer?
- A34. Yes, PSPC will be accepting bids which are priced using catalyzed varnish. Catalyzed varnish is an acceptable equivalent.
- Q35. The breakdown of Milestones in the Basis of Payment, specifically Milestone 2, suggests that the Contractor will not be paid until all wood has been procured for the final manufacturing of the project; when the Chain of Custody document is available. Without approval for the prototype, a Contractor might not decide to procure all the wood upfront. Is it possible to create a distinction between payment for the prototype and payment for the receipt of the Chain of Custody document?
- A35. Yes, Milestone 2 was broken down in Revision 1 to the Basis of Payment. The breakdown is available in Amendment 004 against solicitation EP751-170953/A. This will allow for payment of the prototype to be issued independently of the procurement of the remaining wood for the project.
- Q36. For some groups, only one item is required. Is the acceptance of the prototype for that group considered to be delivery, meaning payment under Milestones 2 and 3 would be issued?
- A36. No. Acceptance of the prototype is independent of the delivery to the site. Acceptance of the prototype will occur in the National Capital Region, but not at the final delivery site. Please refer to Annex A Statement of Work, Part II Scope of Work, Section 2, Item 4, Prototype.
