1. RFI Questions


- .1 RFI Question: Looking at the Drawings for this project, I have noticed that there are several Luminaire Types which are to be new, and are not listed in the Luminaire Schedule:
- 1 Type 102
 - 2 Type 105
 - 1 Type 105A

Response: Fixtures are to match existing. Review fixtures onsite when job is awarded to get exact part numbers but for pricing fixture type 102 is a 2-lamp 32W T8 fluorescent pendant fixture with an electronic ballast. Fixture is equivalent to the Cooper Neo Ray 66-DI-P-2-T8 - 4ft-1-EB.

For fixture type 105 and 105A both a single lamp 6" CFL downlights with 26W lamps. Fixture is equivalent to Cooper PD6H142-62H-C.

- .2 RFI Question: In terms of Security, the spec says to match existing wiring for devices. Little information is given for what is existing. A door detail of where the security devices are located, sizes of conduit needed and types of wire within them would be very helpful.

Response: The existing system is a Lenel Card Access system. Confirm door details onsite with system requirements. Assume the below elevation for pricing.



.3 RFI Question: What is the existing distribution?

Response: As per the electrical drawings we will be reusing and relocating the circuits from Panel 3A. The existing number of circuits is enough after demolition to cover the new renovation circuit requirements.
