**A4. Company supplied equipment**

Q5. Would you consider payment terms of immediate upon receipt of invoice instead of the 30 days?

**A5. Our terms are 30 days**

Q6. What days of the week and times is delivery acceptable?

**A6. Monday to Friday 8am to 4pm (with 48 hours notice)**
