This amendment 004 is raised to answer questions received from industry as follow:

Q.12: There are very few if any bedroom and/or dinette sets and/or sofa and Loveseats available in Canada that are rated or have CSA approval. It is not a requirement for these items to offer them for sale. Certainly the Mattresses/Boxsprings; Bunkbeds and Cribs all have and should require CSA approval but the other items do not. If this is an actual requirement for those items it would severely limit the choices and increase the pricing significantly. Would the Government of Canada accept casegoods that are not CSA rated/approved?

A.12: If a product requires a mandatory CSA approval in order to be sold in Canada, then the bidder must provide a product that is CSA approved.

In Annex B – Furniture Description and Specifications

Delete "The product must meet the regulations under the Canada Consumer Products Safety Act (CCPSA) and must be approved by the Canadian Standards Association (CSA)." from items 1 through 12.

Replace with "The product must meet the regulations under the Canada Consumer Products Safety Act (CCPSA). If a product requires a mandatory CSA approval in order to be sold in Canada, then the bidder must provide a product that is CSA approved." in items 1 through 12.

All other Terms and Conditions remain unchanged.
