**This amendment 003 is raised to answer questions received from industry as follow:**

**Q.06:** On page 11 of 31 of the estimated furniture quantities, since the Ontario standing offer starts July 1, 2017 and ends March 31, 2018 are 9 months and the rest of the provinces are 12 months. Have you based your furniture estimates on 9 months/ 12 months?

**A.06:** All furniture estimates are based on a calendar year (January to December) 12 month period.

**Q.07:** Part 3, Item 3.1, Offer Preparation Instructions - May bidders put the soft copy for all four sections on a single USB key/CD/DVD?

**A.07:** Yes. All four sections may be on the same USB key/CD/DVD. The financial offer must still be excluded from the technical offer.

**Q.08:** Part 3, Item 3.1, Technical Offer - Are bidders required to provide a point-by-point response to Annex A in their submission? What level of detail is required in the Technical Offer?

**A.08:** Please review amendment 1, question 5.

**Q.09:** Under Annex B for single and double bed set:

Single Bed Set including Bed bug mattress and pillow cover set: Box foundation with wooden (100% solid kiln dried wood frame), or metal frame, approx. 39"X 72 to 76", fully assembled upon delivery.

Double Bed set including Bed bug mattress and pillow cover set: Box foundation with wooden (100% solid kiln dried wood frame), or metal frame, approx. 54"X74 to 76", fully assembled upon delivery.

Do you require a mattress, wooden box spring and a metal bed frame? Would we be able to utilize a mattress and metal box spring which no longer requires any wooden box frame?

**A.09:** We require a mattress, box foundation and a metal or wooden bed frame.

**Q.10:** Part 6 – Standing Offer and Resulting Contract Clauses, 6.4.2 Extension of Standing Offer:

If the Standing Offer is authorized for use beyond the initial period, the Offeror offers to extend its offer for an additional four (4) – one (1) year periods, from 1 April 2018 to 31 March 2019, 1 April 2019 to 31 March 2019, 1 April 2019 to 31 March 2020 and 1 April 2020 to 31 March 2021 under the same conditions and at the rates or prices specified in the Standing Offer.
