## **1. CLARIFICATION**

The Contractor will ensure, at no cost to Public Works and Government Services Canada that all personnel follow proper code of conduct for the position assigned. If a person's conduct is deemed unsuitable, the Contractor will be responsible to have that person removed immediately and replaced with a suitable person.

The Contractor will ensure, at no cost to Public Works and Government Services Canada that all equipment and materials are kept in good and safe working order at all times.

The Contractor will ensure, at no cost to Public Works and Government Services Canada that Work is carried out in a safe and efficient manner as per Work Safe New Brunswick.

The Contractor must comply with the Labour Conditions and Fair Wages and Hours of Labour Act.

The Contractor will ensure, at no cost to Public Works and Government Services Canada, that workers have a valid passport in case work is required on Campobello Island during the winter months while the ferry isn't working.

The Contractor will ensure, at no cost to Public Works and Government Services Canada, to coordinate all work.

The Contractor is responsible, at no cost to Public Works and Government Services Canada, to ensure that his/her employees are on site with proper safety gear and material to carry out their duties. In particular, Personnel Protective Equipment (PPE) for construction safety protection as per applicable safety laws and regulations such as safety boots, hard hats, life jackets, and also ensure that employees have proper clothing for wet and/or cold weather.

The Contractor is responsible, at no cost to Public Works and Government Services Canada, to ensure that his/her employees have valid driver's licenses.

The Contractor will ensure, at no cost to Public Works and Government Services Canada, to make sure workers on site are completely conversant with Work Safe New Brunswick Occupational Health and Safety Acts and Regulations.

## **2. QUESTIONS AND ANSWERS**

**Q1:** The equipment required to perform the work such as circular saws, screwing machine, scaffold, drill, etc is payable in which item of the pricing schedule?

**A1:** All regular tools such as hammers, skill saws and like tools, necessary for the work, excluding materials, is to be paid under Mobilization and Demobilization.

**Q2:** To supply men with equipment such as safety helmets and glasses is payable under which item of the pricing schedule??

**A2:** Hourly rate for Personnel listed in the unit price table shall include all overhead costs associated with salaries, meals, and any other materials and safety equipment necessary to complete the work including:  
- safety gear, GPS, smart phone, laptops/ iPad, etc.

**Q3:** Do we have to plan a project officer to make sure of the smooth running of construction sites? In what item of the pricing schedule would we cover this?

**A3:** The Contractor is responsible, at no extra cost to Public Works and Government Services Canada, to ensure that work runs smoothly on all construction sites. There's no item in the unit price table for this requirement. This is incidental to all call-ups under this contract.

**Q4:** Do we have to plan for trailers, telephone, fax machine, water? In what item of the pricing schedule will this be covered?

**A4:** All items not listed in the unit price table is incidental to this contract. Contractor can mobilize temporary facilities such as a construction trailer, temporary water, faxes, etc if he/she chooses, but at no extra cost to any call-ups. The Contractor will be responsible to pay for these items.

**Q5:** In what item of the pricing schedule we have to include the professionals, (Architect, engineer, etc.) if they are required?

**A5:** There is no provisions under this standing offer to provide and pay for professionals (Architects, Engineers, etc). If the contractor chooses to consult with professionals, he is responsible to pay for it, at no extra cost under this standing offer.

**Q6:** If the workers have to have specific training course for work, how will this be covered?

**A6:** Refer to clarification in this amendment.

**Q7:** Does the company have to have a business in the Province of New Brunswick?

**A7:** No

**Q8:** How will the time spent for the estimator/ project leader on projects be paid?

**A8:** Hourly rate for labour listed in the unit price table is the only hourly rate which is to be included in any call-up under this standing offer. Hourly rate is for onsite only. No payment will be made for expenses incurred for estimating or coordinating purposes. No payment will be made for expenses to go check on site before submitting a quote.

**Q9:** If a person has to go on a construction site with a Departmental Representative, how will he/she be paid these spending?

**A9:** Refer to question and answer no. 8 in this amendment.

**Q10:** In paragraph 3 of SI01, it states the estimated amount of the standing is \$15 985 000.00 included taxes – does it represent the total of both the South and the North Standing Offer?

**A10:** 15,985,000.00 represents the total for both North and South combined, for two years.

**Q11:** Paragraph 22 of section 01 10 10 of the specification, how will disposal of construction debris be paid? It is indicated that the Contractor is responsible for the elimination of construction debris.

**A11:** Disposal of Construction Materials, including cleaning the work area, is to be included in Mobilization and Demobilization for trucking/equipment and using the laborer hourly rate. Disposal of construction materials are to be made at Registered Disposal Facilities. Disposal slips are to be submitted to Department Representative.

**Q12:** In the Request for a Standing Offer Document, Annex C, special insurance is required concerning works such as blasting, driving pipe files and underpinning. Will this type of work be required or is this an error in the documents? There are no rates required for equipment and machinery.

**A12:** If this type of work is required, then the work will be within the scope of work provided by the Department Representative. This type of work could be required, this is not an error. Please refer to clarification in this amendment in regards to equipment and machinery.

Section 01 10 10, Paragraph 5

**REMOVE** all reference to “Contract” and **REPLACE WITH** “Standing Offer
