**(1) DELETE SI09 “Industrial Security Related Requirements” Section 1, and REPLACE WITH the following:**

**SI09 INDUSTRIAL SECURITY RELATED REQUIREMENTS**

This document contains a mandatory security requirement for the performance of the subsequent contract (refer to clause SC01 of the Supplementary Conditions included herein).

1. **At bid closing, the Bidder must hold a valid Security Clearance** as indicated in section **SC01 (1)** of the Supplementary Conditions. Failure to comply with this requirement will render the Bid non-compliant and no further consideration will be given to the Bid.

**(2) DELETE SRE 2.1 “Mandatory Bidder Experience” and REPLACE WITH the following:**

**2.1 Mandatory Bidder Experience:** The bidder shall submit one representative project demonstrating the following mandatory Bidder experience:

- 1) The Bidder has performed work as a Construction Manager or as a General Contractor on a construction project where the Bidder's contract was valued equal to or greater than **\$10,000,000**, and the project has **achieved Substantial Completion**, issued between January 1, 2000 and **March 22nd, 2017**.

- a) Description of one representative project the Bidder shall have delivered as a Construction Manager or as a General Contractor with **Substantial Completion** issued between January 1, 2000 and **March 22nd, 2017**.
- b) Total construction value of the representative project at substantial completion.

### **QUESTION 004:**

Thank you for informing us of the decision to change the Security Requirement in Amendment 001. Can I ask why the decision was made at this point and not before the Notice was posted on Buy Sell Canada?

### **ANSWER 004:**

The Contractor/Offerer (Organization) security requirement was omitted from SC01 in the original solicitation documentation by error; only the Personnel security requirement was identified. The update in Amendment 001 ensures the RFP documentation contains all SC requirements for construction projects on Parliament Hill.

If you wish to be sponsored to obtain a Secret FSC company clearance for future requirements, please contact the Contracting Authority directly.

### **QUESTION 005:**

We have received and acknowledge amendment number 001. The interpretation of the documents opens itself to contradiction, do the people who will go to the job showing tomorrow need a valid Secret **or** Site Access security clearance.

### **ANSWER 005:**

No, a security clearance is not required to attend the job showing.
