AMENDMENT #2

THE PURPOSE OF THIS AMENDMENT IS TO POST QUESTIONS AND ANSWERS AND TO ALSO PROVIDE ADDITIONAL AND REVISED DOCUMENTS

1. **Q.** Can you advise whether the contractor will be able to use the Cod Knotts quarry for the production of rock fill and Class A and B aggregates?

A. Refer to the following amendment to the specification below:

Section 31 05 16

ADD:

“Production of rock fill, class A or class B aggregates may be extracted from the Cod Knotts Quarry located in Gros Morne National Park provided all material meets the project specifications. Any existing crushed rock located in the quarry at the beginning of the project must be replaced upon completion of project if used. (what's on the ground now, has to be on the ground when you leave). Upon removal of the detour structure, rock material may be disposed of in the Cod Knotts quarry as approved by Departmental Representative. No royalties or fees will be charged for use of the quarry. All work in the quarry will be in accordance with Appendix D - Cod Knotts Quarry - Rock Extraction Plan.

Co-operate with other Contractors using the quarry in carrying out their respective works and carry out instructions from Departmental Representative. Additional payments or schedule extensions due to work or scheduling conflicts with other Contractors in this quarry will not be considered.

Note: this quarry will not be used for asphalt granulars.”

2. **Q.** Drawing #C01 – “Existing Conditions and Removals Plan” mentions the extension of an existing 1500 mm CSP Culvert. Item # 29 in the unit price table calls for the extension material to be HDPE pipe. I am wondering how the connection is to be made? Or, would a CSP extension be allowable?

A. see attached Addendum.

3. **Q:** Section 01 35 43 1.13.3 of the specification says there are no borrow areas available in the Park. However, apparently there is a borrow area very near this worksite, probably 3-5 km and has likely been used for previous park projects. Will this borrow area be available for this project also?

A: The pit located in Rocky Barrichois will not be available for use.
