19	Detail "A" on Drawing C 208, Rev 6, has a note referring to information being on E200 and E201, these drawings have not been provided. Please supply the missing information, (drawings).	Drawings are to be revised negating the inclusion of electrical reference. The JB and associated components will be removed from the set and new drawings will be posted shortly.	2017-Mar-06
20	With regard to the replacement of curbs adjacent to existing asphalt, currently the asphalt pavement is much higher than the lip of gutter, at what elevation should the gutter be placed, if you want the LOG to be match the edge of pavement, then the grade for the curb will have to be raised. If the intent is to have the asphalt and LOG match, then any sidewalk adjacent to the curb will also have to be raised, please advise.	Widen the section of road to be cut as per the specifications from 0.3m to 0.5m. Taper in the existing asphalt to tie to the new lip of gutter while not changing the existing lip of gutter grades.	2017-Mar-06
21	Is there a disposal site with in the Park for the asphalt, concrete, timber and misc. demolition debris?	The local landfill is the Columbia Valley Landfill. No disposal site exists within the park. The contractor shall complete waste management in accordance with spec.	2017-Mar-06
22	The plans call for the tangent wall to be drilled and poured in proximity to the existing metal bin. In order for this to take place, we indicted to you and the Parks Canada Rep, the drilling rig does not have the reach to drill from the road surface and thus a section of the road would need to be excavated to allow for a solid flat platform to drill the piles. We indicated that we would need the whole right (outside) lane excavated down approximately 1 meter (3+ feet to the top of the existing metal bin). We anticipated this conversation and approval in the minutes. Is this type of excavation allowed?	The distance from the curb is a maximum, the piles can be drilled closer to the curb if desired limiting the slope management and remediation requirements. Equivalent design can also be provided in advance of bid closing should the contractor perceive cost savings while maintaining the same performance requirements in accordance with bid requirements.	2017-Mar-06
