GENERAL

This Addendum forms part of the Contract Documents for **Project No. R.079939.001** and amends the original Drawings and Specifications. The following revisions supersede the information contained in the original Drawings and Specifications issued to the extent referenced and shall become part thereof. No adjustment to the Contract Price will be considered or allowed due to the Contractor or to any sub-contractor or supplier not being familiar with this Addendum.

This Addendum consists of one (1) page. This Addendum is in response to questions from bidders.

1. Confirm if interior walls in the 8 plex have Drywall or are "plywood" paneling.

Confirm wood panelling

2. Are the furniture and appliances to be part of the disposal costs?

No. All appliances & almost all furniture will be removed.

3. 124116 3.5.7, do you have a specification and location for the "pole mounted lockable temporary power panel"? Is this to replace the power line and distribution to and from the carport?

I do not have a specification/ location for the panel. Recommend that the contractor liaise with BC Hydro in order to conduct a site analysis and determine location and line routing design. Specifically for overhead services.

4. The 4 x 2 unit buildings are serviced from an electrical service building near Athlone Road. Will the hydro feed to the service building remain in place? Will the service building remain or be removed?

BC Hydro will have to make the decision for the routing for the remaining services. Of the (2) lines: (1) feed/ connection will require decommissioning and (1) feed will require re-directing.

5. There is a Storage building half way up the driveway, is this building to remain?

Yes. This building is to remain untouched please.

Reminder: The district of Ucluelet will require notification and permitting of demolition works. Also, there is only one main water service for the 8 & 4 plex site. Therefore if services are shut off the occupants must have proper notification.
