#### **QUESTION 1**

In what table for the financial submission do we provide a quote for Mandatory requirements 58-60?

#### **ANSWER 1**

As mandatory criteria 58-60 are service requirement on an as and when needed basis, they are not to be included in the financial tables included in the Request for Proposal. Given the nature of work for mandatory criteria, the required work will be tasked through a Task Authorization which typically includes the following information: the specific task, time required for the task, the contract resources and the per diem for each resources. As such, for the purpose of the submission to this request for proposal, the contractor must provide the per diem rates for the requested resources categories and these will be applied to mandatory 58-60.

#### **QUESTION 2**

We are working diligently on our response to the RFP and understand its great importance. We want to ensure we put forth our best effort and it is with this in mind that we respectfully ask for an extension to the due date currently set for March 14<sup>th</sup> at 2pm.
