This amendment 011 is raised to answer questions from industry.

Q1: We are requesting an extension to April 14th to allow us to complete the detailed RFP response. If this is not possible we could live with April 7th.

A1: Due to project constraints, PWGSC cannot go beyond March 31, 2017.

Q2: We would like to request a clarification regarding the guaranteed payback period as defined in the procurement documents.

Reading section 34.6, the guaranteed payback period will begin on commencement date but in the appendix I, the commencement date should start 6 months after the approval of the energy audit report.

A2: The answer is in Appendix I, Note 1.

The Commencement date begins with the completion of the Improvements, or upon the accumulation of the equivalent of one year's worth of Energy Savings, whichever comes first. In Appendix I, to evaluate the cash flow and buydown conditions, ESCo's are asked to create a simplified cash flow. Note 1 states: This cash flow simplifies the contracting cash flow for evaluation purposes only.

Q3: Can you please confirm that there is still NO CANADA'S CAPITAL COST CONTRUBUTION for this project?

A3: There is no Canada's Capital Cost Contribution identified in the FBI Rigaud solicitation Request for Proposal.

No other changes apply.
