This **amendment # 002** is raised to respond to bidder's questions for **solicitation #K3E35-171044/A** as follows:

Question 1: Per section 3.1.2 with regards to Exchange Rate Fluctuation and inability to adjust pricing due to currency exchange rates for Annex B Option 2 as per clause C3011T.

Our supplier is based offshore and while we are quite confident as to the foreign exchange rate for the next few months, we cannot foresee the rate in 2 years. We would request that clause C3010T be instituted instead to ensure that any price changes for Option 2 are a result of cost of goods increase and not a significant change in currency values.

Answer 1: As we are in a competitive process, Canada will not apply Exchange Rate Fluctuation (Risk Mitigation) with this solicitation.
