This Amendment #3 is raised to answer questions raised by bidders and amend the RFSO where indicated:

Question 1

Under Part 4, Evaluation Procedures and Basis of Selection

4.1.1.1 Mandatory Technical Criteria

M1

Who can be considered to have attended the mandatory site visit? The original site visit was cancelled (Wednesday March 1, 2017 at 9:00 A.M.) and then re-scheduled for (Wednesday March 8, 2017 at 9:00) some bidders attended the first site visit, some attended the second, others attended both and some attended neither?

Answer 1

Due to technical difficulties with the Government of Canada Tendering System - Buy and Sell, not all bidders were able to view the amendment for the re-scheduled site visit. We will therefore be holding a second site visit on March 24th, 2017 for bidders who did not attend the rescheduled site visit. Bidders who attended the March 8th site visit are not required to attend the second site visit. Attending this site visit will be considered to meet the requirements of the Mandatory Site Visit M1 of the RFSO.
