Amendment 001 is raised for the following reasons:

1. To change the bid solicitation closing date from 27- March 2017 to 31- March 2017; and
2. To provide questions and answers.

Question 1:

Our offer, would it be evaluated in case we offer a longer delivery time? What would be the decision date, for a delivery on June 1st 2017?

Answer 1:

As per the evaluation procedures and basis of selection stipulated in part 4, on page 7, of the Request for Proposal (RFP), bid proposals will be assessed in accordance with the entire requirement of the bid solicitation, including the technical and financial criteria.

Based on the projected timeline, the contract award date is estimated to be in April 2017. We expect that there will be approximately six to eight weeks lead time from contract award for delivery of the product, but the actual delivery date will likely be adjusted depending on when the contract award will be published.

Question 2:

In tender documents it is mentioned that the washer must be compact, no larger than 80" in height, 50" in width and 50" in length. The machine that we'll propose is a little bigger than 82" H x 60"W x 65"L. If we quote, would it be considered?

Answer 2:

According to Article 3.3 of the Statement of Requirement, "the washer must be compact in design ideally no larger than 80" in height 50" inches in Width and 50" in length." This means that the suggested dimensions are preferred, but there is some flexibility in providing slightly larger dimensions. However, dimensions cannot exceed 5% of the specified measurement.
