

Q1: Would all training be on Office 2013 at this time, with the exception of Visio (which is 2003)?

A1: As stated in the statement of work under 2.2 Background, the current Microsoft Office version deployed on employees' workstation is 2013.

Refer to the table under 3.2 for the current versions of Visio software deployed on employees' workstations.

Q2: Regarding Access Level 1 and Microsoft Project Level 1 would we be able to offer these at a 1 day in length or is it a requirement to keep these at 2 days.

A2: Refer to the table under 3.2, it is specified "Estimated Duration of Course in days"



Q3: Can you confirm that it is Visio 2003 that you are using?

A3: Refer to question and answer 2 above.

Q4: Please confirm the details of mandatory criteria 01 on page 9 section 4.1.1.1 « The Bidder must clearly demonstrate that it has delivered a minimum of thirty (30) offerings specified in section 3.2 ».
Should we demonstrate 30 courses in total or 30 courses for each of the titles listed in Table 3.2 or 30 courses for each of the titles and levels listed in Table 3.2?

A4: The Bidder must demonstrate having offered at least thirty (30) deliveries in total of any courses indicated in Section 3.2 of the Statement of Work to an external client as of January 1, 2012.

Q5: Does this mean this is only necessary if we have had integrity problems? If we have not had a problem, we need not fill out the document?

5.1.1 Integrity Provisions - Declaration of Convicted Offences

Q6: In Part 4, Section 4.1.2.1 Mandatory Financial CriteriaOption 1 or Option 2, please confirm that this is not relevant to this bid.A6: This sub-section only advises bidders how the evaluation will be completed.

Q7: Page 1: Details on delivery required or proposed.A7: This box indicates the required date of a product or service.

Q8: Page 1: Should this page be completed and attached to our submission? **A8 :** Oui. La page 1 doit être signée et retournée avec votre soumission.

Q9: Page 5, Article 2.2: Our submission can be emailed to your attention? **A9:** Yes. Your submission must be emailed to tanya.lavergne@canada.ca



Q10: Page 8, Article 3.1: Is there a template to be used for Section I Technical Bid **A10:** Annex E shows an example of the Technical Bid. This must be completed and submitted separately from the Financial Bid.

Q11: Page 8, Article 3.1.2 and page 10, Article 5.1: Where can I find the different attestations in Section III to be attached to the proposal?

A11: Section 3.1.2 directs you to give your preference to Annex C for bill payments. With respect to Section 5.1, the links are clearly identified in the solicitation document.

Q12: Beyond sections I to III to be transmitted and annexes B, C and E, what other **A12:** The front cover of the Request for Proposal and the cover page of this modification.

Q13: Under Part 6 "Resulting Contract Clauses," Section 6.2.1 General Conditions references that "2035 (2016-04-04), General Conditions – Higher Complexity – Services" are to apply and form part of the Contract. These general conditions contain Section 19 "Ownership," which indicates, "Unless provided otherwise in the Contract, the Work or any part of the Work belongs to Canada after delivery and acceptance by or on behalf of Canada." The section further discusses transfer of ownership to the Work. – Please confirm it is not Canada's expectation that it will have ownership rights with regard to the intellectual property of the courses and course materials to be provided under this Request for Proposal, if they are standard off-the-shelf courses (with existing materials).

A13: Statistics Canada is looking for a supplier to deliver the courses outlined in the RFP and to provide the training manual in both English and French. Intellectual Property will not be created from this contract.

Q14: The 2035 (2016-04-04), General Conditions – Higher Complexity – Services include a "Copyright" section (Section 20 specifically). This section details that "Materials" are "anything that is created by the Contractor as part of the Work under the Contract, that is required by the Contract to be delivered to Canada and in which copyright subsists." – Please confirm it is not Canada's intent for this RFP to involve Contractor creating any such "Materials" if it already has commercially available IT training courses that will cover the services being requested. **A14:** Refer to answer 13 above.

Q15: Reference: Appendix I 2.0 states the instructor must use the manual in the "designated course language" **when available.** Annex A - SOW Section 3.5 Course materials, states course material including course manuals **must be available** in English and French as required by the Project Authority.

Course manuals are only available in English. Would it be acceptable to conduct the training using English or French software and an English or French instructor as required, while providing the hard and soft copy manuals in English only, and a Quick Reference Card in both English and French?

A15: The manuals must be offered in the language in which the course is delivered, as specified in section 3.5 of the SOW.

Q16: The Government of Canada (through PSPC) is preparing to award a Standing Offer and Supply Arrangement that covers all IT Training Services. How will this award impact the Stats Canada RFSA for instructor based Microsoft Desktop, Visio and Outlook Training?

A16: Statistics Canada is aware of the Standing Offer and Supply Arrangement that PSPC is putting in place. Statistics Canada is looking at putting in place a contract for 1 year plus two (2) optional years.
