Amendment 005

This amendment is raised in order to answer bidder questions as follows:

Question 7) We find in part 1.3 of the General Information section the following clause: "The requirement is limited to Canadian goods and/or services." To the best of our knowledge, all of the hardware (carbon fiber flexible pole, steel cross base, water bag, and rotating ground spike) is manufactured exclusively in China. There are no Canadian or even NAFTA-based manufacturers of those items. Virtually all of the polyester used to print polyester flags and banners is sourced in China. Furthermore, a large majority of the polyester flags and banners sold in Canada are printed in China.

In light of the preceding, what is your definition of Canadian goods and/or services, and what final product will you consider acceptable for a responsive bid? Also, since none of the requested hardware can meet Canadian content requirements, will you consider decoupling the hardware from the banners for the purposes of this RFQ, thus allowing for Canadian content in the banners? Does imported fabric printed and finished in Canada meet Canadian content requirements?

Answer 7) The Canadian Content Policy says, under 2. Application:

- a. The Policy applies to competitive procurements with an estimated value of \$25,000 or more, except for the following:
 - i. government procurements subject to the international trade agreements;

Since the Expositions, Design and Fabrication Services (GSIN T002A) is excluded from international trade agreements such as the North American Free Trade Agreement and the World Trade Organization, and given that this requirement exceeds \$25K, the Canadian Content Policy applies.

In response to your question, the Bidder must be able to certify that the service offered is a Canadian service as defined in paragraph 2 of clause A3050T.

ALL OTHER TERMS AND CONDITIONS OF THE SOLICITATION REMAIN THE SAME.
