- b) open the registration period for additional one-on-one industry meetings for suppliers who missed the second round of One-on-One Industry Meetings, which will be held the week of April 3<sup>rd</sup>, 2017 (by teleconference only);
- c) clarify the registration process for the additional one-on-one industry meetings;
- d) extend the requested due date for the RFI Responses to the second round of engagement with Industry to April 24, 2017 at 12:00pm EDT; and
- e) answer the questions received from Industry.

### **Questions and Answers**

Q1. Is it still possible to register for the second round of industry consultation / one-on-one meetings that will be held the week of March 27<sup>th</sup>, 2017 by teleconference?

A1. Industry can register for the second round of engagement with Industry by no later than April 24, 2017. For those suppliers who would like to participate in a one-on-one industry meeting (by teleconference only) but missed the second round of one-on-one industry meetings, registration for a meeting that would be held the week of April 3<sup>rd</sup>, 2017 (by teleconference only) is required by April 6, 2017. Industry is requested to sign and submit Annex B – Engagement Participation Form of the RFI document.
