AMENDMENT 006

This amendment is raised to answer questions from potential bidders.

QUESTION 8:

Per Phase B1 Technical Deliverables, test report of liner fabric and shell fabric is required with the bid. We would like to check if the test report of previous solicitation of W8486-151419 in 2015 is acceptable. The testing properties are the same but the reference paragraph numbers are different in Annex B.

ANSWER:

Test reports prepared for the previous solicitation are acceptable, so long as the requirements of the latest solicitation are met. Requirements to be aware of when submitting previous test reports include at least the following:

- The section references in the previous reports must be updated/amended to match the references of the latest solicitation, in accordance with s. 6.2.1 and 6.2.6.2.5 of Annex D.
- The reported tests must be conducted by laboratories within the jurisdiction of NATO member states (unless prior written approval has been obtained from the Technical Authority), in accordance with s. 6.2.6.1 of Annex D.
- The reported test measurements must have been performed no more than 3 years before the (latest) solicitation issue date (2016-12-30), in accordance with s. 6.2.6.3 of Annex D.
- Also, the test reports required for the liner fabric in Phase B1 of the latest solicitation differ slightly (see s. 3.3.2.5.1.6.1, 3.3.2.6.1.3, 3.3.2.6.1.13, and 3.3.2.6.1.14 of Annex B.)

These differences could result in previous test reports needing to be updated/amended, or old tests needing to be redone, in order to ensure bid compliance with the requirements of the latest solicitation.

It is the bidder's responsibility to ensure that the submitted test reports meet the requirements of the latest solicitation.

QUESTION 9:

We would like to ask for an additional one month extension to end of May.

ANSWER:

A one month extension has already been granted, as per amendment 002. Due to time and scheduling constraints within the Bid Evaluation process, an additional extension will not be granted.

QUESTION 10:

We also want to know more about the patented design/material/liner coating question that was answered in an amendment. If we do have patented or patent pending products, will this be seen as a negative on our application?

ANSWER:

The patent status of your products and bid deliverables will not affect the bid evaluation results.

All other terms and conditions remain unchanged.
