Question 1:

SRE 3.1.1 Licensing, Certification or Authorization states

"The proponent shall be an experienced civil engineering firm...."

Whereas the terms of reference state that "PWGSC requires the services of an architectural firm, acting as prime consultant..."

Please clarify.

Answer 1:

Replace paragraph "The proponent shall be an experienced civil engineering firm, licensed, or eligible to be licensed, certified or otherwise authorized to provide the necessary professional services to the full extent that may be required by provincial or territorial law in the territory of Nunavut."

With

"The proponent shall be a(n) Architect, licensed to provide the necessary professional services to the full extent that may be required by provincial or territorial law in the territory of Nunavut.

Question 2:

The Nunavut Building Code Act defines an architect as a person who is licensed to practise as an architect in a province to territory.

Please confirm that an architect registered to practice in Ontario is considered by PWGSC to be qualified to act as architect and prime consultant for this project.

Question 3:

The Nunavut Building Code Act defines an engineer as “a person who is qualified to practise professional engineering under the Engineering and Geoscience Professions Act (Northwest Territories). Please confirm whether engineers acting as sub consultants must be registered to practice engineering in the North West Territories.

Answer 3:

Yes, engineers must be registered to practice engineering in the North West Territories.

Question 4:

The RFP includes a requirement for the building envelope specialist to be certified by a nationally recognized certification board, and identifies the North American Air Barrier Association as an example. In fact, there is no National certification board for building envelope professionals. For example, the certification available through NABA is aimed at installers and not design professionals. Will PWGSC accept, registration as a professional engineer and a statement of previous experience in building envelope design as credentials for the building envelope specialist.

Answer 4:

Proponents who include a building envelope specialist with formal training, such as certification through NABA, will receive a higher point grade in that area than those firms who don't include this member on their team. However, it is not mandatory.

Re: Terms, Conditions and Clauses Agreement 1. (b).

Please clarify whether R1250D (2015-02-25), General Condition (GC) 9 stipulates, requirement for Professional Liability Insurance in the amount of \$1,000,000 per occurrence.
