The division offers a wide range of services which includes designing and developing electronic questionnaires. Over 160 survey questionnaires, primarily from the business sector, have been migrated to EQ while the majority of social surveys which are much more complex to design are scheduled to migrate within the next 5 years.

The OID Questionnaire Design Centre is responsible for the User Experience design of Electronic Questionnaires. This includes creating screen designs and flow charts which can be used to render input files for the Electronic Questionnaire Generation System (EQGS).
