#### **1) REQUESTS FOR CLARIFICATION**

Q1. In Section SRE 3.2.3, the RFP requires only the two structural bridge engineers and the two structural dam engineers be included in the proposal text. However, Appendix A – Team Identification Format also includes two mechanical engineers, two electrical/controls engineers and a cost consultant.

Please clarify which personnel are expected to be included in the proposal section “Achievements of Engineering Team Members”.

A1. Please see below Revisions to the RFP – Appendix A –Team Identification Format – Revision 2; and SRE3 Submissions Requirements and Evaluation- 3.1 Mandatory Requirement – 3.1.2 Consultant Team Identification.

Proponents shall provide two Structural Bridge Engineer Team Members, two Structural Dam Engineer Team Members, one Electrical Team Member and one Cost Consultant Team Member for Engineering Team Members under SRE3 Submissions Requirements and Evaluation- 3.1 Mandatory Requirement - 3.1.2 Consultant Team Identification.

Only two Structural Bridge Engineer Team Members and two Structural Dam Engineer Team Members will be evaluated under SRE 3.2.3 Achievements of Engineering Team Members to be Assigned to this Project.

- .2 Removal of the existing dam deck and replacement with new members
- .3 Rehabilitation of the substructure to accommodate construction of the new bridge superstructure and minimize impact to the existing discharge capacity

  - b. Repainting of all steel dam components including gates; gains; mechanical housing and railings.
