1.0 QUESTIONS & ANSWERS

1.1 Q. Architectural drawing A.008 -3rd floor demolition plan shows that the existing restrooms on 3rd floor will remain. However the plumbing drawing M-103 shows all the plumbing fixtures at 3rd floor restrooms to be demolished and associated piping to be capped off. Please clarify.

A. Plumbing fixtures shall remain with all associated piping. They will be removed and replaced in the T.I fit out contract to meet Green Globes water efficiency requirements and is therefore outside the current scope of work.
