Amendment 003 has been raised to:

- 1) Provide a revised time for the optional site visit.
- 2) Provide response to bidder questions.

- 1) The time for the Optional Site Visit changed has changed.

The Site Visit start time is changed from 11:00am to 12:00pm (Noon), to accommodate bidders taking the 9:10am Schwartz Bay-to-Pender Island ferry (arriving at 11:35am). This should allow mainland bidders to take the 7:00am Tsawwassen ferry terminal -to-Victoria ferry prior, which arrives in Schwartz Bay at 8:35am that same morning.

For bidders arriving by seaplane, seaplane space at the facility is limited. There is no provision for seaplanes to stay at the facility after unloading passengers, and that if there are other seaplanes or vessels using the facility, moorage is on a first come/ first served basis.

**Q1:** The date of the site meet has changed, but catching the first ferry from Vancouver to Sydney and then the next ferry to Pender Island will land us on Pender at Otter Bay at 11:35 AM. I assume that this will have us arriving only 15 to 30 minutes late for the site meet at Bedwell Hbr. and it will not be a problem.
