Solicitation Amendment 004

This solicitation amendment is raised to address contractors' questions. All other terms and conditions remain unchanged.

Questions from contractors:

Q1. Do we need to supply lights for his tower, and what is required? On a recent bid to CCG they supplied the lights but asked us to install them.

A1. Light supply or install is not part of this contract.

Q2. Does CCG have a facility near this facility that can be used for staging?

A2. The nearest CCG facility is in Prince Rupert that can be used for staging if requested.

Q3. Are all antennas that are identified as initial to be installed and are tx materials provided?

A3. Antennas will be installed by CCG at a later date. Contractor to supply and install the Tx brackets and antenna mounts for the initial antennas.

Q4. Due to the logistical complexities involved in this project is it possible to for an extension from the closing date of Wednesday 26 to Friday the 28th of April?

A4. Closing date has been extended to May 1, 2017 as per Solicitation Amendment 003.
