Item 3.5 (e) Exchange Rate Fluctuation (17 of 75)

PWGSC states that exchange rate fluctuation risk mitigation is not granted. PWGSC has offered mitigation in other contracts in the past and we request the same consideration.

ANSWER #001

No changes will be made to the existing clause. Because Canada will use the the yearly Statistics Canada's average Industrial Product Price Index (IPPI) for Plastic and rubber products to adjust the prices during the option years, Bidders are required to mitigate their risks in regards to the exchange rate fluctuation.

QUESTION #002

Can we provide our sub-contractor's references for Table A – Mandatory Requirements or do we need to show proof as the bidder?

ANSWER #002

If the Bidder itself did not perform the work, the Bidder must provide proof of experience by their sub-contractor by submitting contract with invoices, or any documentary evidence to that effect.
