Amendment 001 is being raised to answer the following questions:

Question 1: Could you advise if a topographical and/or legal survey is available for the site?

Answer 1: A legal survey was completed in 2012 and the data will be available to successful consultant.

Question 2: We recognize the scope of work is clear with respect to excavation of PCB impacted soils and backfill with clean fill material. However, we also note that there are additional "Outstanding Issues on the Site" described in Table 3.1 of Stantec's 2013 RAP report, namely metal debris and tires, concrete tower bases, creosote poles and other potential physical hazards. Could you confirm whether these outstanding items are also to be included in the design for the subject RFP?

Answer 2: The additional outstanding issues on the Site are not to be included in the design for the subject RFP.

Question 3: RS 3.0 Section 3.1 Intent-What are the structural, mechanical and electrical systems contemplated in this proposed work? Please confirm these do not apply.

Answer 3: Structure, electrical, mechanical do not apply.

Question 4: RS 3.0 Section 3.2 Scope and Activities Item 3.2.8. - We understand that Canadian Broadcasting Corporation, Nav Canada, Bell Aliant and Canadian Coastguard have lease agreements. Where are these tenants activities in relation to the proposed work area?

Answer 4: Tenants are not located near the proposed remediation work and no special attention re impact is required.

Answer 15: Consultants are required corporately to have appropriate H & S in place to perform their normal work activities. If the consultant plans to visit the Site as part of their design function, they will need a Health and Safety Plan specific to the Work and Site. Therefore, the preparation is part of RS 3 if the design consultant is planning on visiting the Site at all? The On-site Contingency and Emergency Response Plan can form part of the H & S Plan in general terms of indicating Emergency Contacts and identifying Site escape route, any evacuation measures and operational procedures. The Site is not an operational facility so the information requirements will be a lot less. The Onsite Communication Plan will be carried out by PWGSC in-house and the consultant will not be responsible for preparation.
