This amendment 001 is being raised to correct the solicitation and answer supplier questions as follows;

A) In **ANNEX A – REQUIREMENT - Deliverables under the contract**

1. **ACCOMMODATION:**

- c) Have a current valid Saskatchewan Permit to operate a food service establishment

B) **Questions and answers:**

Q1a: Annex A #1 & Mandatory criteria #1 states vendor must provide exclusive use of the accommodations. Does the client mean that if a dormitory is used cadets and the public cannot share a dormitory?

A. That is correct

Q1b: Am I right to interpret this that if a hotel is used for the rooms, as long as the individual rooms for the group are private that 'exclusive use of the hotel' (meaning no other bookings allowed) is not necessary?

A. That is correct

Q2. Would the client consider changing the distance from the training center to 10.3 km instead of 10 km?

A. Yes.

Q3. Will lunch be eaten at the training center?

A. Cannot answer this question, as it will depend on the Flying conditions and training schedule and to be determine by the Flying instructors on daily basis.

Q4. Would it be acceptable to have the lunch meals delivered instead of picked up by the group in the morning?

A. No. Meal delivery could be a problem with Flight line access, timelines, and security.

Q5. As my company is not a direct food service provider or direct accommodation complex and thus does not have the specified permits in Mandatory criteria 4 & 5.

A. As long as the provider as the specified permits, this will be allowed.

Q6. My company works with local providers to arrange and provide the service and has successfully executed two similar Department of National Defence contracts within the past year and in process of executing two more internationally, will you amend the criteria to state that the bidder must provide the required permit for the facility and not directly that the bidder have the required permit?

A. Same as above.
