Q.16:

There seems be an error in the matrices of panels; you ask for glass sections of 18Hx 54L but on the plans you indicate that the glass panels are of 18 H x 24W. PLEASE specify

A.16:

The glass panel are 18H x 54W, the plans has been corrected.

Q.17:

There is also an error in the plan in panels in front of handwritten table of 24 " of deep where we see the dimension TA3054 instead of TA2454 and there is no panel of 30 " in your rises of panel(sign) (see certain plan of floor in the bottom(stocking) to the right the indications of colors). PLEASE specify.

A.17:

The good dimension considered is TA3054, the table of 54 x 30 will face the screen of type C which is of 54W x 36 H. On whom will be added a covered in frost panel of 54L x 18H.

Q.18:

PLEASE specify the location of small columns. The location of lamps in the ceiling would be also useful to avoid any conflict with the positioning of small columns.

A.18:

The location of small columns are indicated on plans. We added a plan of the ceiling indicating the location of lamps.
