### **Optical Communication Contribution Concept Study**

This Amendment 002 provides an answer to a question raised by one potential bidder as of May 3rd, 2017.

#### **Question #1:**

In relation to the Government Furnished Information (GFI) mentioned under the section 3 – Technical Description of the Statement of Work (on page 5), would it be possible to obtain document titles and high level content with bidders (or this will be known at contract award only)?

#### **Answer #1:**

*Such GFI, if any, would only be provided after contract award simply because there is no such GFI at this point in time and it is not expected that such GFI would become available until the next few months. As stated publicly, the Canadian Space Agency, along with other partners of the International Space Station (ISS) are elaborating the future international post-ISS human spaceflight and space exploration missions. The high level information pertaining to this initiative is available in the public domain on the web. The progress towards the definition of an architecture for telecommunication is ongoing but still not very meaningful at this point. Once it becomes mature enough, it will most likely be provided as GFI to the chosen contractor.*
