Question No. 2

Regarding the ELECTRONIC MAJOR CASE MANAGEMENT solicitation M7594-161712/A could the Crown please confirm that a bidder may submit a response as sole vendor in order to qualify to receive the RFP, however upon receiving and reviewing the specific requirements of the RFP they may then decide to form a bidding team, add sub-contractors or enter into a joint venture with a vendor, or vendors, that may not have been participated in the initial RFRE process.

Answer No. 2

Yes, confirmed. Respondents can form a bidding team, add sub-contractors, or enter into a joint venture following the initial RFRE process. Note as per Section 3.1(e), A Respondent to the RFRE can only submit one response.
