Part 6 - Standing Offer and Resulting Contract Clauses; B. Resulting Contract Clauses; 6.4.1.3 Exchange Rate Fluctuation Adjustment

Delete: 4 and 5

Insert:

4. The initial exchange rate is typically set as the daily exchange rate as published by the Bank of Canada on the solicitation closing date.

5. For goods, the exchange rate for adjustment will be the daily exchange rate as published by the Bank of Canada on the date the goods were delivered. For services, the exchange rate for adjustment will be the daily exchange rate on the last business day of the month for which the services were performed. For advance payments, the exchange rate for adjustment will be the daily exchange rate on the date the payment was due. The most recent daily exchange rate will be used for non-business days.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED
