AMENDMENT 003

This amendment is being raised to respond to questions submitted in response to solicitation 5P420-17-5043/A.

A. QUESTIONS AND ANSWERS

- Q1. A1 of section C of 5P420-17-5043A_Addendum_01 states (incl.) "There is no lane rental fee for the no work period. Detours or single lane alternating traffic are not permitted.", and section 1.5 of the Tender Specifications states "one lane of traffic must be provided at all times". Are we allowed to stage the work (i.e. single lane alternating traffic with traffic lights or a flagger), or is the requirement to have 2 operational lanes at all times? The referenced clauses contradict each other?
- A1. The second part of answer 1 provided in addendum 1 refers to the **no work period only**, i.e. that detours or single lane alternating traffic are not permitted during no work periods. There is no conflict between Cl. 1.5 of Section 01 11 00 (Summary of Work) and the response provided in the addendum.

Contract Award Date (tbc) - June 15, 2017: One lane of traffic must be provided at all times.

June 16, 2017 - Sept 5, 2017 (No Work Period): No works are allowed during this time. Two operational lanes of traffic must be provided at all times for the duration of the no work period.

Sept 6, 2017 - Nov 15, 2017: One lane of traffic must be provided at all times.

Nov 16, 2017 - Apr 3, 2018 (Winter Shut Down): No works are allowed during this time. Two operational lanes of traffic must be provided at all times for the duration of this period.

Apr 4, 2018 - June 15, 2018: One lane of traffic must be provided at all times.

- Q2. As per addendum 1, the stage 1 work will be completed in the fall of 2017 with the Stage 2 work being completed in the spring of 2018. There is 30mm of concrete being removed from the existing deck with 50mm being placed back leaving a 20 mm differential between the 2 sides of the deck during the winter months. Will there be any additional work required to alleviate this situation?
- A2. Addendum 1 does not require that Stage 1 is completed in the Fall of 2017 and that Stage 2 is completed in Spring of 2018. The Contractor is required to plan and execute their work in the permitted months and to ensure that the bridges remain in a state suitable for safe open/public use and for winter maintenance activities.
- Q3. There appears to be a utility conduit attached to the East side of the 3 bridges, can you please advise what utility company owns this and what is inside. Who will be responsible for the temporary relocation of this conduit?
- A3. The utility is owned by Telus. The results of a third party locate titled *BVP_Locates.pdf* are provided for information, this does not absolve the Contractor of their responsibility to verify the location of any utilities in the area. The Contractor is responsible to protect, divert, temporarily support or relocate the utilities as per Cl. 1.4 of Section 01 14 00 of the specifications.
- Q4. Bid Item 13 15, the linear meters for the Estimated Quantity, is width of deck (for block out concrete removal) plus length of both wingwalls (for the upper wingwall concrete removal)?

 Ex. Johnston Creek Bridge (5.7m + 5.7m + 3.625 + 3.625) * 2 = 37.6 meters
- A4. The quantity of concrete removal on the abutments is the sum of the length of the removals on top of abutment back wall and abutment wing walls. Please note that the example provided has a mathematical error.

All other terms and conditions remain the same.
