This amendment 03 is raised to answer questions and modify the solicitation as follows:

1 - QUESTIONS / ANSWERS :

Q.04: We've found a few additional discrepancies between the "Office Consists of" List/ Typical and the CAD Floor Plan:

A) **Office Type 2b:** The "Product Consists of" List requests a 24"x48" Height-adjustable Table - Code 2-2 for FSCAEA4824. This Typical corresponds with Offices 437 and 440 on the CAD Plan.

In the CAD Floor Plan:

B) Office 437: The height-adjustable table size is 42"x24". (Noted and drawn)

C) Office 440: The height-adjustable table size is drawn at 42"x24", but noted 48"x42". Which makes this office 6" bigger than drawn on AutoCAD.

D) Please confirm if the height adjustable table (Code 2-2) FSCAEA4824 should be FSCAEA4224 for Typical OFF2B (Office 437 and 440)?

A.04:

A) Office Type 2b "Office Consists of" List should be stating a 2-1 FSCAEA4224 rather than a 2-2 FSCAEA4824.

B) Correct. Notes as 2-1 in furniture plan.

C) Refer to Furniture plan issued 2017-04-20. Office 440 is showing and noting table 2-1 which is 42 x 24. Not sure what plan is noting a 48x24, but it would be out dated.

D) Office 437 and 440 are to have table 2-1 as noted in the Typicals plan and furniture plan.

Q.05: We have found one more discrepancy. This is between the Annex A: Product Category 3 – Table 1 and the Annex C "Product Consists of" Lists for the Offices Typical

Annex A: Product Category 3 – Table 1 (page 16) requests for GoCUID: LLFC2DFDxxx1836xxxx (Qty 16) and LLFC4DFDxxx1836xxxx (Qty 5). Total of 21 Filing Cabinets.

Annex C: The Product Consists of Lists for all the Typical Offices request for "Locking Lateral File Cabinets" with GoCUID Code LLFC2DFDxxx1836xxxx only. Total of 21 Filing Cabinets for 23 Offices.

5.a Which Filing Cabinet would you like us to price? LLFC2DFDxxx1836xxxx? Or LLFC4DFDxxx1836xxxx? And in what quantities.

5.b The Total Quantity of (21) Filing cabinets correspond with Annex A and Annex C, however, The CAD Drawing show two additional Filing Cabinets Code No. "1b-9" in the hallway, outside of Offices 429 and 430. Total Quantity of (23). Please confirm if Total of (21) or (23) Filing Cabinets required for Offices?

A.05:

A) Not all offices will have a 2H file cabinet. Only 16 offices will have them (refer to furniture plans). 2H file cabinets (qty 16) and 4H file cabinets (qty 5). The 4H cabinets are in open office areas (refer to furniture plan)

B) 1b-9 is not a file cabinet. This is a wardrobe for the adjacent offices.

1b-9 for every office (2 in adjacent hallway) plus one additional one in reception (total qty. 24)

3-1 = 2H file cabinet (qty 16)

3-2 = 4H file cabinets (qty 5)

Q.06: we need some clarification on how Cat 1a/1b and Cat 2 will be evaluated as the height adjustable tables from Cat 2 are in the typical for Cat 1a/1b which leads us to believe they will be evaluated together. However, the format of the forms shows that Cat 1a/1b and Cat 2 will be evaluated separately as there is a separate table for each Category.

Please confirm if Cat 1a/1b and Cat 2 will be evaluated together or separately.

A.06: The rule for Category 1 & 2 as per the RFB document will be applied, therefore Category 1 & 2 will be combined.
