Enquiries - Bid Solicitation - Clause # 2.3

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here are other questions which we have received until now:

Question 4: In the Port of Québec, certain wharfs are subject to limitations in range and, on the other hand, access to the port for non-standard transportation is restricted. Also, unusual transportation may require "ministère des Transports, de la Mobilité durable et de l'Électrification des transports (MTQ)" permits and a precisely defined route. We would like to know what wharf number at the port of Quebec should we deliver?

Answer 4: Unfortunately, we are not in a position to answer this question because it is the responsibility of bidders to determine the logistics of transportation and unloading at a wharf in the Port of Québec. Bidders must determine themselves at which wharf in the Port of Quebec they can deliver and unload the pre-filter.

Question 5: Do you already know who is the carrier (barge) to bring the pre-filter from the Port of Québec to Mont-Joli?

Answer 5: It is unknown at the moment and it will not be known for a few weeks. Bidders must bid without this information.

All other terms and conditions of the bid solicitation remain the same.
