9	This bid is solely for equipment supply, does not require a dry docking and or work on the vessel, we would like to request PWGSC to be so kind to add a Limitation of Liability.	Limited liability clauses N0001C will be added to the Contract terms and conditions.
10	Would it be possible to extend the closing date for the bid. Is it possible to extend the closing date for the bid with 2 weeks?	The closing date for bids is extended to Thursday, 1st June 2017.
11	For the vessels to have robust, sturdy and proven system with accurate readings, not disturbed by vibrations of the deployment system and with a reasonable survey speed, the suggested deployment system as indicated in Annex "A" Statement of Requirement, paragraph 1. General Terms, part d, and other parts that indicate a powered ram system, will not be the right solution. A drop keel deployment system ensures the optimization of the high quality sensors and allows for a higher maximum survey depth and higher sea bottom swath coverage as a deeper operating frequency can be used in this case. A drop keel system is the best solution however has a larger impact on the ship's structure than a ram deployment system. Would a	Any proposed solution must match the configuration and operational constraints identified in the original Statement of Requirements. The proposed solution must be power activated for deployment and retrieval, it must fit within the physical constraints identified and be protected when in a retracted position to prevent damage while the ship operates in sea ice. It must be self-contained and be configured such that work can be conducted on the transducers onboard the vessel while a sea, hence the requirement of a docking bay with access at the heeling compartment level as witnessed during the bidders conference.

12	Assuming a contract award date early/mid June that means a 4 months lead time for the complete system, including deployment/retrieval system for the first vessel. This is very short. Would it be possible to extend the lead time to 10 months after contract award date?	The first sounder system shall be delivered no later than 15 March 2018 and the second system no later than 19 April 2018.
13	Looking at the calendar and what needs to be done to complete the bid and send hard copies, I would like to know if it would be possible to submit the bid electronically, by e-mail, and / or get a 1 week extension on the bid deadline. 3) Add N0001C to the Contract Clauses in the Request for Proposal

ADD: 6.11 Limitation of Contractor Liability

1. This section applies despite any other provision of the Contract and replaces the section of the general conditions entitled "Liability". Any reference in this section to damages caused by the Contractor also includes damages caused by its employees, as well as its subcontractors, agents, and representatives, and any of their employees.
2. Whether the claim is based in contract, tort, or another cause of action, the Contractor's liability for all damages suffered by Canada caused by the Contractor's performance of or failure to perform the Contract is limited to **the Contract Value**. This limitation of the Contractor's liability does not apply to:
 - a. any infringement of intellectual property rights; or
 - b. any breach of warranty obligations.
3. Each Party agrees that it is fully liable for any damages that it causes to any third party in connection with the Contract, regardless of whether the third party makes its claim against Canada or the Contractor. If Canada is required, as a result of joint and several liability, to pay a third party in respect of damages caused by the Contractor, the Contractor must reimburse Canada for that amount.
