AMENDMENT 003

This amendment is being raised to respond to questions submitted in response to solicitation 5P420-17-5087/A:

A. QUESTIONS AND ANSWERS

- Q5. Are there additional drawings besides the Transfer Station to reference the proposed paving and patching required at the Campgrounds?
- A5. Yes see Figures 1-3 from Amendment No. 001.
- Q6. The milled areas (50mm depth) is assumed to be "full depth" and left in place and then in turn reshaped, prepped and paved on top of?
- A6. Yes but it's expected that the millings are removed and disposed of off-site by Contractor. The existing granular material is reshaped and paved on top of.
- Q7. Is there an estimated total areas of patching? Will there be any saw cutting, removals or other prep required for asphalt paving?
- A7. Refer to Figures 1-3 (Amendment No. 001) for the location of the patch repairs. Refer to detail TCS02B for the Tapered Pavement Joint requirements of overlaying and the Measurement and Payment Section for work included in the bid items.
- Q8. Are campground locations able to be closed during construction or will traffic be required to pass through?
- A8. Limited closures within campground loops are permissible for short durations (up to 1 hour). The successful contractor is required to coordinate with Departmental Representative, as part of the Traffic Accommodations Plan, to minimize the disruption to visitors. Full closures of campground main roads and loop access roads is not permitted.

B. SPECIFICATIONS MODIFICATIONS

- 1. Section 01 27 00 (Measurement and Payment). Clause 1.4.25.5, add:
 - 1.4.25.5 In campground overlay areas (Whistlers, Wapiti and Wabasso), include in the unit price of the asphalt concrete paving, the following costs:
 - .1 In areas with existing asphalt, include the cost of milling and installing a tapered transition, as shown in the details.
 - .2 In the areas with chip seal, or gravel surface, include the cost of tapering the asphalt to match the existing surface

All other terms and conditions remain the same.
