Question No. 6

Can reference projects include those of both the Respondent and its proposed subcontractor with respect to a team response to the RFRE?

Yes, reference projects of both the Respondent and its proposed subcontractor with respect to a team response to the RFRE will be considered.

In 3 (a), will the Crown change the wording from "...deployment of *the* Solution..." to "...deployment of *an investigative major case management* Solution..."?

Question No. 8

Section 3.2 Item 2. Operational Capability.

The Respondent must have completed one reference project where the Solution is currently deployed in a production environment, and

a) Has been used in an active investigational policing environment for at least three years;

Would the Crown consider broadening the a) requirement above to include the justice, public safety or military environments as these often form part of police (multi-agency) major case management investigations?

Answer No. 8

No, unless it is being used in a policing environment within that organization. For example, Military Policing would be acceptable.

Question No. 9

Section 3.2 Item 4. Product Functional Capabilities.

4. b) Has been in use in a production environment in at least two policing organizations for at least three years prior to the closing date of the RFRE.

Would the Crown consider broadening this requirement as follows?

4. b) Has been in use in a production environment in at least two justice, public safety or military organizations for at least three years prior to the closing date of the RFRE.
