1) answer potential bidder's questions

Q1: ANNEX A describes two project phases, the first of which focuses on the chamber envelope (fire protection, HVAC, lighting + video, and "RF window" replacement). Can we assume all of the first phase modifications will be completed when we arrive onsite to install absorber?

A1: Yes

Q2: Will all existing absorber materials be removed and the shielding prepared for new absorber installation once we arrive onsite? If yes, what date is this expected to be complete, so we can consider when to perform the shielding inspection?

A2: Yes, the tentative date for this is November 20th 2017.

Q3: Annex E - What is the intended difference between line items 4 ('ATF-2 RF Performance Test Plan') and 5 ('Testing of Absorber and Final RF Performance Test Report')?

A3: The test plan is indeed required in the proposal as per RFP documentation. Annex E will be modified to remove RF Performance Test Plan from the pricing sheet.

Q4: As long as proper materials and procedures are followed, can various absorber pieces be cut and painted onsite?

A4: Yes

Price-per-Point: Total bid price is divided by the corresponding total technical score achieved by the bidder for its technical proposal, to determine each bidder's cost-per-point.
