-	With regards to Solicitation 10052461, and further to Question 5 of Amendment 1 and Question 19 of Amendment 2, we respectfully request an amendment to R1 for 3 reasons:  1) R1's current format appears to allow only utilization of TBIPS contract references within SSC for compliancy. Given that SSC has been fully responsible for the Federal Government's Data Centre, Network/Email and their Security operations it makes it unlikely that any TBIPS contracts outside of SSC will be compliant as R1 references. This appears to be overly restrictive as it would exclude suppliers that have provided large Data Centre, Network and Security professional service solution references through other contract vehicles such as SBIPS, Agency specific contracts, and direct to large private sector enterprises.  2) There is no such restriction for only TBIPS references at SSC in the mandatory component of this RFP, yet by assigning 60 points out of 160 in the rated criteria, this restrictive clause in R1 effectively becomes a mandatory requirement.  3) This restriction has not been seen in any other large SA RFP that SSC has released in the last several years as Industry expects the crown to be open and inclusive as it pertains to the procurement of Data Centre, Network and Security professional services.  As such, we respectfully request the crown change R1 to allow for bidders to either:	SSC will allow contracts other than TBIPS to be used as reference in response to R1. Vendors must show how project references match and comply with TBIPS' category criteria if procured through a vehicle other than TBIPS.
