Description of Work:

NRCan requires:

- Up to two (2) Senior **Programmer Analysts** to address changes to the *ERS Report Generator*, which produces the ERS reports handed out to the Homeowners. NRCan is planning on contracting one (1) Programmer Analyst immediately, with the plan to hire a second Analyst being dependent on additional program needs and budget decisions that will take place in Fiscal Year 2017-18.
- One (1) Senior **Programmer Analyst** to address changes to the *ERS System* specifically MAILBOT, OMNIS, PV Upload and Shared Services applications.
- One (1) Senior **Database Analyst** to address and manage changes to the *Housing Database* and associated databases, that link with the applications noted above under the *ERS System*.
