- b. *These Bidders must immediately inform Canada in writing of any changes affecting the list of directors during this procurement process.*

As Bidders have already submitted the Declaration at the time of submitting an arrangement under the Request for Supply Arrangement (RSFA), the Declaration form for procurement does not need to be submitted, however Bidders must immediately inform Canada of any changes affecting the list of directors during the procurement process.
