## 1. Questions and Answers 1 through 3:

#### **Ouestion:**

1) On page 21 Section 1.3 there is a clause that talks about the Contractor being able to use the pre-wired outlets at no charge but that the contractor would be responsible for ongoing maintenance. Are you able to elaborate on where this responsibility would end in regards to the existing cable distribution? Would it strictly be the coax cable to the back of the wall plate or is it something else?

#### Answer:

1) The contractor shall provide a CATV system in accordance to SP1000R1E Statement of Technical Requirements (STR), Cable Television Distribution System, For Use In Federal Correctional Facilities. The existing CSC institution CATV network is distributed via coax to a wall mounted metal plate via a F88 connector. The contractor may reuse the existing CATV infrastructure. The contractor is responsible to verify signal levels in accordance to the aforementioned STR.

Please see the Statement of Technical Requirements for Cable Television Distribution System and Commissioner's Directive CD-341, Reception and Distribution of Television Signals for your reference.
