QUESTIONS AND ANSWERS

Question No. 12

Mandatory Qualification Criteria #2 (Operational Capability) and #4 (Product Functional Capabilities) require that reference projects be limited to those with policing agencies only. Surveying the industry, it is clear that a very limited pool of solutions can meet this requirement, although solutions do exist with the required operational and functional capabilities. In order to allow for a competitive tender, with multiple bidders offering an array of best-in-class solutions that increase the value provided to Canada, will Canada modify the mandatory qualification criteria referred to herein to allow references from other similar environments in justice, public safety and security, and the military rather than limiting the criteria to policing environments only?

No, RCMP will not modify the mandatory qualification criteria referred to herein to allow references from other similar environments in justice, public safety and security, and the military. Please see Questions and Answers 8 and 9 of amendment 4 for further clarification concerning references.
