**Question:** 4.1 Equipment Summary table indicates quantity 4 of the C-1.5-120:11/V type cameras; where are these to be located within the facility?

**Response:** See the RFP document which should show you everything you need to know. There is also a zip file which has both an AutoCAD drawing and a pdf copy showing where the Cameras are to be placed. These type of camera are anti-grip corner mounted camera for detention cell.

Note that there is an error in the list of camera:

- Camera A1-28 is type D-1.2-100/V

The summary table becomes:

- C-1.5-120:11/V: 3 only are needed instead of 4
- D-1.2-100/V: 14 cameras are needed instead of 13

**Question:** Are as-built drawings of the current installation available? Can details of the fiber routing and current network distribution be provided?

Traffic Building

Bidders have requested PDF of drawings, as-built drawings and drawings identifying the new camera locations.  
Existing cameras are to be taken out  
Existing locations will remain but be slightly modified  
Pictures of the server room was allowed  
Cable is to be run via open channels or J hooks  
Server room allows rack or j-hooks in the ceiling  
Bidders need to consider the 10,000 BTU cooling capacity in their bid  
CCTV real estate in the server room – how much is available ? - Bidders can use the space where the server is now and some empty rack space. Wall mounted racks are available.  
An LPR camera at the Primary Inspection Lane (PIL) is required.  
Multiple fibres are running to the traffic building from the outside poles/cameras.  
Existing fibre and power can be used.

CAT5 Cable in between both buildings to be replaced with Fibre  
Server room was viewed
