SOLICITATION AMENDMENT #1

THIS AMENDMENT CONSISTS OF QUESTION AND ANSWERS TO THE ITT AND AMENDMENT TO THE SOLICITATION CLOSING.

1. ANSWER QUESTIONS ASKED BY POTENTIAL BIDDERS.

QUESTION AND ANSWERS

- Q 1 The documents are deficient as relates to delivery of the units. Kindly confirm Parks Canada will undertake to:
- a. Off-load the units from transport at Honey Harbour?
- 1a Parks Canada will not coordinate off-loading the units at Honey Harbour. It is the responsibility of the contractor to coordinate off-loading the units.
- b. Store or float and moor the units at Honey Harbour?
- 1b Parks Canada will undertake to float and moor the units at Honey Harbour
- Q- 2 Alternately, is it expected the units will be constructed at Parks Canada drydock in Honey Harbour and 'turned over' to PC in drydock?
- A-2 It is expected that the units will be constructed off-site and transported to Honey Harbour. Parks Canada does not have sufficient space for the units to be constructed on Parks Canada property in Honey Harbour.

Q-3 Kindly provide Specs for metal panel systems (wall and soffit applications)

A-3 The metal panel systems are James Hardie cement fiber 4x8 ft sheets with revealed edges and surface mounted screws (with countersunk holes and screws). These James Hardie cement fiber panels to be installed exactly as per the manufacturer installation with fastening system specified. Reference can be made to the following link:

The exterior storage closet doors are with wood siding "Urban" prefinished, brushed face in Modern or contemporary provided by Maine.

The exterior storage closet doors are Hardie panel cut into boards and installed with 10 mm gaps for ventilation as shown on drawing A203 and details A802.



Q-4 Why is there a Spec for wood siding when none is shown?

A-4 Conventional practice to provide specification for possible future revision requests

Q-5 Why is there a Spec on wood doors when none are shown?

A-5 Conventional practice to provide specification for possible future revision requests

Q-6 We have a Spec for hollow metal doors but the main door, as shown on drawings, appears to be a residential door. (c/w wood frame?)Drawing A900 refers to 'prefinished' doors. There is no such thing available in hollow metal or residential doors. All need painting post-delivery. Clarify. The toilet door refers to 'solid panel type'. Does that mean a plain slab? And is this also a residential entrance c/w wood frame.

A-6 This is a plain slab residential entrance door with wood frame

Q-7a) Windows are to have thermal break frames with single pane glazing?! That makes no sense. Clarify.

A-7a- Intended to comply with standard frame sections available, not a custom section

7b) notwithstanding the floating units cannot be occupied without having window coverings installed, confirm same are NIC.

A-7b- Window coverings are NIC

Q-8 FRP is spec'd for toilet room walls. To what height? And what is fibreglass baseboard? Should that be FRP base? Ceiling in toilet room shows as exterior grade plywood which is inappropriate and unsightly. Clarify

A-8 Refer to drawing A103 for full height FRP and base. Plywood ceiling specified

Q-9 Provide a Spec or model/source for stainless dock ladder.

A-9 Stainless steel ladder is NIC

Q-10 Provide Spec on grey-water storage tank.

A-10 Grey water totes system: Barker Manufacturing - 15 gallon P/N 11747

Q-11 Provide Spec on waterless toilet.

Q-13 Is the entire Solar Panel System NIC? There is little reference to it on Electrical Dwgs. And how are Solar panels fixed to roof? Later, by others once mooring is complete?
