1	<p>Section 3.0 of the Specifications (Annex B) specifies "Dark Blue" as an exterior color.</p> <p>Question: Is there an actual paint code of this color that you require? Is that paint code a standard GM paint color?</p>	<p>There is no specific code. Correctional Services Canada (CSC) will accept any shade of dark blue offered by vehicle manufacturers upon approval by CSC Technical Authority.</p>	No.
2	<p>In annex B, Item 3.0 Brake warning indicator, requires an audible alarm and a cluster telltale warning light.</p> <p>The audible alarm (chime) is no longer available with the required manufacturer's Ambulance prep package found lower down on the same page.</p> <p>Question: Is it possible to delete the requirement for the audible alarm (chime). This would leave the brake warning system as a telltale instrument light.</p>	<p>An audible alarm or chime concurrent with the illumination of the "Brake Warning" light is a desirable feature and a mandatory requirement if available as standard or optional equipment from the proposed chassis manufacturer. The requirement is N/A or "Not Applicable" in the event it is not available from the proposed chassis manufacturer. In such an event check the "Y" column, and in "Comment" column indicate "Brake Warning Indicator provided, audible chime not available from proposed chassis manufacturer".</p>	No.
