32	Regarding article 1.4.3.1 in section 01 53 00, it states that we are to use Chain Link fencing for the storage area, but in the description, there's mention of Heavy Duty Welded Wire Fence. Please clarify which one is required	Bid as per plans and specs, section 01 53 00, 1.4.3
33	RFI 006: "We are to protect most of the baseboards on the ground floor as per the Heritage Action Plan, but per the Heritage Protection Plan and the Demolition Plans we are eliminating most of the partitions. Are we salvaging the baseboards? For example; Room #254. Heritage Action Plan shows the baseboards as covered terrazzo and we are to implement action "P" Retain and Protect. In the Heritage Protection Plans and Demolition Plans, we are eliminating all the walls in this room. What shall we do with the baseboards? 36	The new plans show sloped insulation in the roof composition. An inverted roof system does not have sloped insulation; no supplier will approve this. What is the existing roof assembly? Bid as per plans and specs. Sheet AD1 08 contains notes instructing the
