



5. Response to bidder questions (Q&A)

QUESTION 1: Any reason the speed requirement are really low?

ANSWER 1: The 4 plans stated within the Statement of Work indicates the

service functionalities required based on our existing client base current usage patterns. They represent the current download and

upload speeds that a user of the service would expect to

experience. These data speeds do not represent what the carrier speed that the proposed infrastructure is planning to use in the background. The bidder may propose any type of infrastructure with carriers set to whatever efficient modulation/coding and/or carrier transmission speed, just as long as any user has access to

the posted speeds listed in the plans.

We understand that a satellite network may offer higher transmission rates than those stated under the 4 plans listed in the SOW. We welcome other plans that can offer higher speeds under the Published Price List (PPL) section of the RFP, however our evaluation of the proposal will be based on the 4 stated plans.

QUESTION 2: There is no Plan 5 on the Request for Proposal (RFP) document?

ANSWER 2: Bidders shall note that contrary to what was previously stated in the

original version of Annex A1- Appendix A and Annex A2-Appendix

A, there are only 4 speed plans and not 5!

The same would apply for Annex B1- Appendix A and B2-Appendix A. Please find the update documents replaced by this amendment.

ALL OTHER INFORMATION RELATED TO THIS SOLICITATION, REMAINS UNCHANGED
