INTRODUCTION AND PROJECT OVERVIEW

- CSC is upgrading the CCTV systems at PRA Minimum institutions; these bidders meetings were held with contractors and the Institutions to discuss project requirements and identify equipment locations.

REQUIREMENTS - QUESTIONS AND ANSWERS

- **CAMERAS** – All existing cameras to be removed and replaced with new digital CCTV equipment
- **MONITORS** – Existing monitors to be removed and replaced with new except where otherwise identified during the site visits and in the STR
- **WIRING** - All existing analog wiring to be removed and replaced with new Fibre and network cable except where otherwise identified during the site visits and in the STR
- **ACCEPTABLE SYSTEMS** - Only systems that have been tested and deemed acceptable by CSC will be allowed to be installed.
- **RACK** - Locations for all equipment racks and CER/MCCP room determined during the site tour.
- **STORAGE OF MATERIALS** – Space for a Sea Container available at all minimum and healing lodge sites. CCC's identified storage areas within the facilities.
- **MISCELLANEOUS / QUESTIONS:**
New camera locations identified during site tours, STR and maps updated to reflect changes
Tower specs were requested to be provided for bidding purposes and will be included with updates.
